### Instructions to candidates for Document Verification

1. Document Verification is scheduled at Jharkhand Public Service Commission, Circular Road, Ranchi – 834001 on **08.12.2022** from **9:30 AM** onwards.
2. Call letter for document verification will not be issued, Candidates need to show Aadhaar card for identity along with the copy of email sent by Commission in this regard.
3. **If a candidate fails to attend for document verification on the specified date, his/her candidature for Interview will not be considered.**
4. Verification will be done for all the documents which have been enclosed with the application provided for Advt. No. - 04/2018 and additional relevant documents(which were not enclosed with the application provided for Advt. No. - 04/2018 but have been provided through email on email Id-[ap42018@jpsc.gov.in](mailto:ap42018@jpsc.gov.in) for marks/increase of marks claim) with the related original documents. So, Candidates are directed to bring all the related original documents and provide those to the verification team for verification. For claim of marks for Experience as per clause 6(ii) of the advt. Candidates must also bring self attested copies of Appointment letter/Notification.
5. Candidates must bring two recent passport size photographs.
6. Regarding Caste certificate and certificate of Physical disability (if applicable) candidates must refer point No. iv of Information and Instructions to candidates regarding provisional marks uploaded on Commission's website on 21.11.2022.
7. NOC (No Objection Certificate) issued by competent authority from the present employer (If applicable). Original NOC along with one self attested photocopy of NOC should be provided to the verification team. If original NOC have already been provided with the application for Advt. No. - 04/2018, then the same should be communicated to the verification team.
8. Candidature of candidates called for document verification is purely provisional.
