Instructions to candidates for Document Verification and Interview

1. Call letter for document verification and Interview will not be issued, candidates need to show Aadhaar card for identity along with the copy of email sent by Commission in this regard.
2. If a candidate fails to attend for the document verification and Interview on the specified date, his/her candidature for Interview will not be considered without any notice.
3. Candidates are directed to bring PowerPoint presentation (Maximum 10 slides and 10 minutes only) for his/her 'Domain Knowledge and Teaching skills' in a Pen Drive and provide it during the Interview. Candidates can choose any topic of their choice for slides pertaining to Teaching skills.
4. Verification will be done for all the documents which have been enclosed with the application provided for Advt. No. - 05/2018 with the related original documents. So, candidates are directed to bring all the related original documents and provide those to the verification team for verification.
5. Candidates must bring two recent passport size photographs.
6. NOC (No Objection Certificate) issued by competent authority from the present employer (If applicable). Original NOC along with one self attested photocopy of NOC should be provided to the verification team. If original NOC have already been provided with the application for Advt. No. - 05/2018, then the same should be communicated to the verification team.
7. Candidates who have been directed to submit document(s) (mentioned against the names in the provisional list of candidates found eligible for Interview) will have to provide two(02) self attested photocopies of the document(s) and show the original copies of these document(s) for verification. If the sought document(s) are not provided during document verification then scanned copy of self attested photocopies of sought document(s) must be emailed to email id – ap52018@jpsc.gov.in till 12.01.2022, otherwise their candidature and/or marks claim will not be considered.
8. Candidature of candidates called for document verification and Interview is purely provisional. Candidature will be decided in light of document verification and document(s) sought(if applicable).
9. Note for candidates who have been directed to submit caste certificate
 - i. For SC and ST category candidates
 - a. Candidate's Caste certificate issued in the name and address of father in format mentioned in the advt. is valid if it is issued not below the rank of Sub Divisional Officer.
 - b. Candidate's Caste certificate issued in the name and address of father in form-IV as per circular No. - 1754 dt. - 25.02.2019 of Jharkhand Govt. issued by Circle Officer is valid.
