3. Candidates are directed to bring PowerPoint presentation (Maximum 10 slides and 10 minutes only) for his/her 'Domain Knowledge and Teaching skills' in a Pen Drive and provide it during the Interview. Candidates can choose any topic of their choice for slides pertaining to Teaching skills.
4. Verification will be done for all the documents which have been enclosed with the application provided for Advt. No. - 05/2018 with the related original documents. So, candidates are directed to bring all the related original documents and provide those to the verification team.
5. Candidates should bring two recent passport size photographs.
6. NOC (No Objection Certificate) issued by competent authority from the present employer (If applicable). Original NOC along with one self attested photocopy of NOC should be provided to the verification team. If original NOC have already been provided with the application for Advt. No. - 05/2018, then the same should be communicated to the verification team.
